We, the management and staff of Pineywoods Camp, are grateful for the adults who are willing to give of their time and serve during summer camp!!! As an adult Sponsor, each of them is expected to be a leader and a guide. They participate in summer camp to lead kids/teens to Jesus and to train them to serve Him. Part of a Sponsor's job at camp is to diligently observe the kids/teens in the group. It is to protect the kids/teens at camp, the ministry of Pineywoods, and the integrity of your church.

This encampment operates under an annual permit issued by the Texas Department of State Health Services and is required to operate according to the requirements of the Texas Youth Camp Safety and Health Act.

Our policies, rules, and procedures reflect those requirements. Like the camp organization, each adult at summer camp must comply with the state regulations and meet every requirement for those supervising kids/teens:

- (1) Annual criminal and sex offender background checks
- (2) Completion of a state-approved sexual abuse and child molestation training program
- (3) A character and integrity reference provided by you via the Pastor Reference Form (next page)

Regarding background checks, the following types of criminal convictions or deferred adjudications will preclude him/her from attending camp.

A misdemeanor or felony under Texas Penal Code:

- Title 5 (Offenses Against the Person) excluding a Class C misdemeanor under §22.01 (Assault)
- Title 6 (Offenses Against the Family)
- Chapter 29 (Robbery) of Title 7
- Chapter 43 (Public Indecency) or §42.072 (Stalking) of Title 9
- §15.031 (Criminal Solicitation of a Minor) of Title 4
- §38.17 (Failure to Stop or Report Aggravated Sexual Assault of Child) of Title 8
- Any like offense under the law of another state or under federal law

Sponsors will be required to complete an online commitment form at a later date, but we are asking for your help prior to our processing and clearing each adult to serve at camp.

**WE ARE ASKING YOU
TO PRE-SCREEN PROSPECTIVE ADULT SPONSORS PRIOR TO COMPLETING
THE PASTOR REFERENCE FORM!!!**

Know the adults. Know if there are issues or convictions that would preclude them from attending camp and/or consequently working with the kids/teens at your church.
